

Gene Doyle Celebrates 50-Year Career—So, Who is Gene Doyle?

Gene just happens to be our Crosswoods Newsletter graphic designer and website administrator.

Gene's professional career spanned 50 years from 1967 to 2017 beginning as Art Director for WLEX-TV and WKYT-TV, then as Creative Director for Henderson Advertising and finally as the President of his own ad agency, Creative Media (since 1982.)

Gene is widely known as Kentucky's first commercial animator and has created work seen nationally for such notable clients as General Electric, Hotpoint, Heublien International, Kentucky Fried Chicken, Long John Silvers, Bluegrass Coca-Cola and the American Dairy Association, along with an extensive roster of other local and regional clients.

His volume of advertising industry accolades included multiple, ADDY, TELLY, AFTRA, and PIAS awards. He has articles published in numerous magazines including The Lane Report and is past Chairman of the BBB's Truth In Advertising Committee. Gene is also an accomplished oil painting and watercolor artist.

Gene chose the month of April this year to retire and has handed his stable of clients over to a young up-and-coming advertising agency, Oculus Studios in Lexington.
