Other Business:

The light at Old Coach is still not working. Everett or Mark will call an electrician to make repairs.

Everett will call Lawnworks to turn on the sprinklers for all 3 entrances and make repairs if needed. The water company must unlock the meters before this can be done. Mike at Lawnworks will call the water company.

Peter and his wife, Elizabeth, planted 5 knockout roses at the Old Coach Entrance. Pete is planning to plant grass seed at the Crosswoods entrances in April. For these reasons, the sprinklers were turned on early.

Everett will call Grant's Lawn and Garden service to inform him that volunteers will be maintaining the entrances for Crosswoods I and II.

Lindsey Ball of the Jessamine County Health Department has issued a notice to Stanley and Diane Gross of 101 Crosswoods Place to abate the nuisance according to KRS 212.210. The notice states that they are hereby notified that, after examination, a nuisance dangerous to the public health (or source of filth or cause of sickness) exists on the premises and must be removed. They were warned that if they fail or neglect to do so, the law provides that they will be fined or taken to court. Lindsey called Everett to provide an update. She said a certified license septic installer was hired to correct the septic problems at this location and work should begin soon.
