Meeting Minutes for April was reviewed. Joe made a motion to accept the Minutes, seconded by Sondra.

The *Treasurer's Report* for April was not available for review. Mark reported that seven new paid members were generated by the latest newsletter mailing.

Other Business:

The light at Old Coach is still not working. Everett or Mark will call an electrician to make repairs.

Pete reported that the wetlands cell has been fixed. There was an additional 180 feet of lines installed along with an alarm system. The neighbors in this area are satisfied with the resolution. Also, the neighbors have asked Judge Cassity to investigate the Health Board and counsel staff on the length of time that it took to resolve this public health issue.

Pete reported the work that he has performed on the Crosswoods I entrances. The islands have been dethatched, straw added, and grass seed planted. Pete also weeded the flower beds. He has been reimbursed for the price of the seed.

Everett reported that he had called Grant to let him know that we were not going to be using him at this time. There currently are volunteers helping on the landscape maintenance of the entrances.

There was some discussion on whether the lawsuit for the North Jessamine Fire tax had been filed. Mark thought that the lawsuit was still on hold. Other discussion included the information that Judge Cassity and Dennis Traynor are asking the Fire Dept. to help with health emergencies until the EMTs arrive for North Jessamine.

Becka has picked up the banner for the annual neighborhood yard sale. She also reported that she had delivered 2 baskets to new neighbors.
